We will comply with the School Admissions Code, which has the force of law. In respect of in-year admissions, Gunnersbury School is the admissions authority. The information you provide to us on your Supplementary Information Form (SIF), any supporting papers or appeal documentation you provide will be used to:

- Process your application
- Consider Admission Appeals

We may also use this data for the following purposes:

- > To assist in the development of policy proposals
- > For the prevention and/or detection of crime or fraud
- For research and statistical purposes when we will ensure that statistics are developed in such a way that individual children cannot be identified
